The fire extinguishing system erected by the licensee of the Govt is sound and efficient. According to certificate A the fire prevention materials have been inspected and it is found to be satisfactory.

After that the said certificate of Non – destruction shall remain Valid for a period of one year from the date of issue you will be solely responsible for obtaining the fire safety certificate Also during inspection Ensuring that the fire prevention and life protection measures found will continue in the future should be taken.

- 1.Automatic detection and alarm system should be installed.
- 2.(Co2 fire Extinguisher) should be installed in place of panel board,

As per Maharashtra fire Prevention and life protection Measures Act 2006 given below Compliance with terms and condition will remain mandatory.

- 1.Maharashtra fire prevention and life Saving Measures Act Rule No.3 by the applicant (developer, owner, occupier or by whatever designation) fire prevention & life saving measures 2006 and National Building Code of India 2016 and from time to time there in implementation will be mandatory as per the amendment made. This law will not be violated and this should be taken with Caution.
- 2.Section no.of the said Act.Fire prevention life preservers by the applicant as per clause 3 of 3 a letter from the licensed agent to be effect that measures have been taken certificate and in good repair and working order as specified in sub-section (1) Certificate in prescribed form to be maintained B chief Fire Officer one per year times (in the months of January and July) Should be submitted.
- 3.Fire prevention equipment installed by any person in his building or part there of will not spoil. Will not modify it, cut it or any of it will not harm or cause any person to do so.
- 4.After the fire prevention measures in the said building are in good condition as well as in this earlier system you may not have received notice of any errors or any fire at that location. This certificate will be accepted only if the incident has not occurred.
- 5.To be imposed as per Maharashtra fire prevention and life Saving Measures Act 2006 The amount of difference in case of fire service fee/Municipal fee if it is wrongly imposed then it need to pay at the time of issuance of Certificate.
- 6.Subject to the fulfilment of all the conditions given in the temporary clearance certificate and no other changes shall be made and if any changes are to be made in he said building, the changes shall be extended by informing the undersigned.
- 7.The undersigned reserves the right to make additional instructions subject to frequent changes in the constitutional provisions, subject to these terms and conditions, the said " Non Exemption Certificate is being given."
