TERMS AND CONDITON:

1. Primary and upper primary schools are required to comply with the provisions of Right of Children to free and compulsory Education Act 2009 and all rules framed thereunder and further would be made there under, as the case may be.
2. Management of the eligible schools who are complying with the provisions of the Act, 2009 are hereby permitted to open schools in the academic year 2017-18 as follows,
 - A) Those management who has been made eligible by the Government Resolution for the year 2017-2018. If these management do not have all the necessary facilities as per the prescribed rules of the Government for the establishment of school or upgradation then, it will be mandatory for them to comply the same within 18 months from the date of this government resolution for establishment of the school failing which the permission given will automatically be cancelled.
 - B) Those school Management/ Education society willing to affiliate to the curriculum of the Board of Education like CBSE,IB,IGCSE and CIE etc. Who have been made by eligible and grandted permission based on the Government Resolution dated 20 June 2012 comprehensive guidelines shall apply for procuring No objection Certificate (N.O.C.) to the Government. Those concerned schools fulfilling all the prescribed terms and conditions shall be granted affiliation to the Board of Education by the Government.
- 3) The new schools/Upgradation school granted permissions, shall comply with all the order and procedures issued by the Government from time to time as well as shall be bound to comply with all the provisions of Maharashtra Self-Financed Schools (Establishment and Regulation) Act 2012 and (year 2013 of one.)
- 4) No Change shall be made in future in center of school location etc from that of sought by the society at the time of school permission. If the school is established at the place other than the place where permission has been granted by the government, the permission given by the government will be treated as automatically cancelled
- 5) U-Dise data:- While filling the information in district wise U-DISE (Unified District information System for Education) about the established of permitted new school/ up gradation schools by this government decision,

The responsibility of registering the school in the separate category and getting the number will be on the concerned organization by record in a separate category as “approval granted on self-financed basis school”

The Government has declared the State Project Director, Maharashtra Primary Education Council Mumbai as the nodal officer to take further action in this regard. Similarly, for the information of all concerned, the society should put up a notice board outside the entrance of the school stating, ‘Self-Financed basis approval granted new school/upgradation school”

It shall be mandatory to implement the exiting prevailing rules and policies of the Government and such rules as may be prescribed by the Government from time to time. Based on the above terms and condition this office is hereby granting approval of the first account.
